CES Annual Meeting – Beth Young – Beth and Adam attended the 1st Annual Conference Planning Committee meeting. The Conference locations will definitely be at a hotel December 16, 17 and 18 2019. The 1st day will be JCEP and CES Association Meetings. Due to concerns from 2018 – the JCEP meeting will be first followed by the CES Annual meeting. They are planning at least 4 breakout sessions and need suggestions from support staff.

Professional Improvement – Adam Ziadeh - Discussion: Marianne mentioned that professional development scholarships should be part of the awards offered by JCEP. Lively discussion concerning our merge with JCEP and how to apply the Membership and Annual Meeting scholarships:

- Need to promote the benefits of joining
- Need to clarify CES is now JCEP
- Annual Meeting Scholarship will be transferred to the recipients chartfield after the fact
- Need to remember to include Emeriti in the email blasts
- Need to coordinate with JCEP membership due date
- New members scholarships = \$20.00 for affiliate JCEP membership
- Returning members = \$30.00 (?) to apply to full JCEP membership
- Be clear that Membership dues will apply 2020; Annual Meeting Scholarship will apply to 2019 Annual Conference

Annual Conference Activities – Beth Young nothing at this time **Recognition** – nothing

Mentoring – Ashley Gerber – nothing to report

Excellence in Extension Award – Paige Matney is working on this. Lee Ann proposed that following the naming conventions of the other Excellence Awards presented at Annual Conference, we might wish to think about renaming our award. The Extension Support Staff Excellence Award was patterned after ESP. ESP has the ESP Extension Excellence Award which is presented to the outstanding educator being recognized each year. Chi Epsilon Sigma should be referenced somewhere in the name of the award. Suggestion would be to include CES in the name - Chi Epsilon Sigma and Extension Support Staff Excellence Award. We could name it after Dorothy Rex also but already have the Dorothy Rex Inspiration Award. Because this award is in the Constitution and Bylaws, we likely cannot rename for the 2019 Annual Conference but would have to for 2020 after voting by the membership on the C&B. A motion needs to

be made by the board on how to propose this change in the C&B. Also Lee Ann asked that we make sure that the CES logo is used on our awards.

Old Business:

JCEP Meeting Report – Beth Young and Adam Ziadeh – next meeting is October 21st.
Other Old Business – Adam Ziadeh – Need a CES Vice President by October. Please contact Adam if you would like to run for this position or if you would like to nominate someone.

New Business:

- TERSSA Update Christina Byrd TERSSA conference registration is now open and due on October 1st. The Conference will be held at Mississippi State and runs November 1st. 20. At this time, we may have 4 to 5 delegates attending. The new TERSSA website is up and running (TERSSA.org)! TERSSA award nominations are due November 1st; Officer nominations are being requested. TERSSA is also looking for an historical list of members and their years of membership. Linda will look through her files. The 2020 conference is scheduled to be held in North Carolina. The TERSSA.org website is not working for everyone (unable to open). This will be looked into.
